Inetrview with Lynch William 14.7.47.

His master.

Benjamin
or Cyril

I met William Lynch moving around the houses of Daniel Griffiths andhis soms: Cyril and Ariffither Eric. "Whose is this house?" - I asked pointing to one of the houses. "This is my master's house" - was his answer. I stopped for a couple of hours and he told me his family history.

His bastard parents.

William Lynch was not born in Warsop. He was born in St. Elizabeth, where his mother was born and stayed all his life. His father was James Lynch, whose house in on the other side of the Baptist Church. He was a bastard child. "My mother - St. Elizabeth is her home. She never lived in Warsop since I come big. I born St. Elizabeth."

His childhood in Warsop.

Still as a child he was transferred to Warsop and brought up by his grandmother, Mary Lynch, the mother of his illegitimate father. "When I come here, I was a small child, 4-5 years. I was living at my grand-mothers home, Mary Lynch." He spent in his grand-mother's home all his childhood.

His marriage.

He married some 17-18 years. He was not reguralry married, but has been attached to a girl in the neighbourhood, daughter of Cyril/?/ Griffiths. He left her grandmother's home and stayed imaker with the family of his woman. "I lived withknex in my father's home, before I moved to my own. I lived with my father-in-law and with my brothers-in-law. With the father of my wife.

His own property.

He got nothing from his parents. "I am a bastard. James Lynch, my father, give me nothing. I get nothing from myxparanex from none of my parents. Have nothing when I started to live by my own." Nothing at all from my own father."

About 10 years ago he bought however a little over 1 stretch of land from his grand-mother, Maxry Mary Lynch, and built his own home. Ordinary grass-house. I this way he managed to live on the same property where family place, where he spent his childhoof, and to have at the same time a home of his own. He paid 14/. to his grandmother for this land. It was "backland" and this was the reason why the price was low. Still he was expected to support his grandmother.

His marriage.

He married his wife regularly /in the Chur h/ some nine years ago. "9 years since we married. When I marrix I was strong, I was striving for myself."

His two-family home.

"At that time I was still mx with my grand-mother. I did not renting any land. I worked the land of my grandmother. My wife was at my father-in-law house. I marry her before my grandmother die. I built my house and stayed in my house. All the time I visit my wife's home, and I visit my grand-mother's home just the same. My wife took her washing to wash. I worked the land of my grand-mother. I was trying to my best to help her. At that time an I was strong.

Death of the grandmother.

His grand-mother died 7 years ago. But he got no land from her property. She owned wasuk "around 5 acres land". She got only this one stretch of land, which he bought pre viously. All the ranki remainder of his grandmother's land was taken by her "lawfull" sons. Nothing was given to the "bastard" grandson.

Successors to the family property.

There were several Lynches who were xucan related in this or other way to Mary Lynch, his grandmother, and were expected wir heirs of the family property. Only some of them garxsonsxpr inherited this land; others got nothing. Altogether the land passed to William Lynch's uncles. Only lawfull sons inherited the land. Unlawfull grandsons got nothing.

Lynches in Lynch Town. James Lynch, William "bastard father .

There are following Lynch families living now in

Lynch-Town or in its vicinity. There is first of all James Lynch, Williamss Thurstan "bastard" father. He lives with his family on the other side of the Baptist Church. He gets no help from his fa-ther and does not expect any. "James Lynch - he wealthy, but he don't help me. He help lawfull, but not bastard. Many a times I ask him to give me land - he never give. Not even promised to give anything. He wont give me anything." Why? "Bad man."

Johny Lynch, his pat.uncle. uncle.

Johny Lynch, who lives right in the middle of Lynch Town "is my uncle". He is brother of James Lynch. Joseph Lynch, Joseph L. He lives in vicinity of Johny Lynch - "my uncle". another pat. Also "brother of James Lynch". he is "very poor, poor-Also "brother of James Lynch. In the poor". "He live family land, has wathit no own land, they poor". "He live family land, has mathit no own land, they dont share the family land". /The land is shared by the sucessors to old paternal property, but not subdivided./

Renard Lynch.

Remard Lynch - his house is at the bottom of the hill, on which Stephen Whate's house is situated. "We are two first cousins; but he is wealthy, him go to America, stay in America now. " His house does not stay emty now: "a little old lady living here, name Gee /MalaGee/, I dont know the right name, she dont married".

Renard Lynch is illegitimate son of Stephen White. "Menard Lynch's father was Stephen White. His mother was Margaret Dwyer. She was M rgaret Lynch, but she married a guy name Dwyer. Him father /Renard's/ is a very rich man and him help him. He sent money to his father and his father buy lands for him."

Stanley Lynch.

Stanley Lynch is another illegitiemate son of James Lynch. "Him my brother. We two bastard sons. He is different mother, not the same, but also unlawfull." His position is however much better. "He was taken by old good lady, Mrs. White. The old lady died and left him lands. She was no relation to Stephen White." And no relation to Mrs. White who lives on the top of the hill eastwards from the Mission House. She left him "good amount of land. He is about to leave to live in Mount Happy". He sold his land near the parochial road to Mount Happy to Augustus Napier from Allsides and intends to move to Cockburn. "He has some land in Cockburn, plenty of land. He got it from the old lady."

The old lady "took him as a child." She took also a girl who was from St. Elizabeth and brought two of them, Stanley and the girl, as her adopted children. She left the land to Stanley and added the girl to it. The girl is "suckly". There is another girl living in Stanley's house: "two of them stay in home". The other /"Mummy"?/ is Stanley's wife. "They don't marry yet, but they live

tokether".

Frandmother's land subdivided among successors. When his grandmother died, "her sons took all the land". "Before she die, she promise to give me. I was looking for something, but her sons took everything: Joseph, John, Fred, Roebrt. Them took the land, them took all-all. Around about 5 acres af land. Only one stretch me." He could not prevent this. "I could do nothing. For me is the grandchild, and them is lawfull sons."

James Lynch did not participate fully in the succession "James never got anything, for him - he leave and go alone by himself". After a while, William admitted that Lynch got a piece of land from his mother's succession. "He got a piece of land at the bottom of the hill and sell it to a stranger. Renard Lynch bought it from James. He is an uncle to him, he call James Lynch unche. "But, as far as I could understand, all the familyland reamined still undivided - all the successors use it and share in common, but they did not cut it into separate posses ions. Only James Lynch is excluded from this collective family owhership.

William Lynch's farm to-day.

He plants some yams and cassava on this spot. Last year he akanted x some xx had some 70 yam-hills; this year "I buy and try to put 100 hills." He has "couple of roots of banana" at his house and "a couple of root of cane".

This is all his cultivation.

How he does make his living? waxthin "Sometime I go around and work for a better man and get 2/., and sometime cant earn at all." Maxwifexmerk "My wife work for nobody." Brothers-in-law? "They don't help me." Father-in-law? "Him don't help me."

His living.

His work.

"No, working for nobody - the same place, my own premises."
To-day/Monday/? There was "nothing to-do." To-morroe?
"My own little gardening." Wednesday? "Just the same, same position."

His health.

In fact, he cant work now. He is ill for about 5 years. "I loosed my health, I cant do nothing for myself, I am sickly." What a trouble with him? "Sickness - in my head." II was working and got a fall in Cockburn." He hurt his head and back, went to a doctor, but the hospitals were overcrowded at that time, he could not get the admission. Doctor gave him some medicine and told him that his nerves are overstrained from work. This happened 5 years ago. "To-day I am down."

He is not able even to work his own land. "All the good people help me all zem arou d." Now he got also some

"some dreadfull pain in my stomac".

His family.

His family consists of 6 persons: himself, his wife and four children. He His oldest girl, 16 years old, does not stay with him. "him is not in Warsop; in Mandeville, working - domestics." "3 months since she left;. HEXEX A week ago he got kaxk letter from her. She works still in Mandeville as servant. She did not stay previously in Warsop with the family; was in St. Elizabeth with her grandmother and his mother.

Icent Lynch is his another daughter. She also is described as "the eldest". She is 17 years old and goes to the school. His sen, Alva Lynch, is onyl 14 years old.

He also goes to the school.

The youngest child is a boy 8 years old. His name

is henneth.

How they make living?

William Lynch was very vague about how do they manage to make their living. He does not work, his wife does not work, his children do not work. They rent 1/2 acre of rented land and one stretch of their own under the house. His father-in-law does not help him, neither his brother-in-law. But he was found wandering about his family-in-law place and described this place as "his master's house".

Religion. Education. William Lynch does not belong to any church. His mother was Anglican, his paternal family are all Baptists. He is illiterate. He went to the Baptist school at en he was a boy, not only on Sundays, but learned mothing. "I go by week, but I never took an education." His children go not to the school, but they do it irregularly. "One week they go, another week they stay home. The up little water, doing something in the garden."

Adventists.

I asked him about S.D.Adventists in his town. He was very much impressed with Adventists services here. "great multicute" coming to the service in the local meeting house on Saturadass. "A great multicute of them last Saturday." "Sometime around fifty." "Great multicute." The meeting house is not however belonging to the Adventists. This is the meeting house of the converted people.
