## Interview with Gerald Dyer

Sunday, Gerald 26, is the son of Alland Dyer Now dead July4, 1948, and Lydian Dyer also dead.

> Ed. F. Household: He shares a 2 roomed hosue he had built with his own money, with Bernet Roye, a sister's son. The premises on which he lives adjoins Annas Dyer's.

> > This interview was given on the Wintward Elliott premises which is being "overlooked" by Ezra Gordon. I had called to see Gordon, whom I found sitting on the grass under a mango tree, xxx eating mangoes and talking with 2 other men (not identified, save for Gerald who was one of them. )

Gerald was wearing a pair of shoes, newly laundered clothes in good condition, and a felt hat also in good condition. He was curious about what the surve is all about. He was told; he seemed satisfied.

## The house and land:

His house is one of 5 built on the land of 152 acres. On his father's death in 1937, (his mother had died in 1924) the land was jointly left pfor his children Neither his mother or father had children had childre by any other union.

Gerald began building his house in February 1946, and completed it in December 1947. Children for whom the premises are left and alive to his mother andi father are:

1. Naomi Dyer. She is in America. 2. Zemina Dyer. She lives in her own house on the pre premises.

3. Dudley Dyer: he is atailor living and operating in Kingston.


4. Zillahvine Dyer; She lives on the premises.

5. Bradley dyer; he lives on the premises. 6. Gerald Dyer; i.e. himself; he lives on premises. 7. Lucille Dyer; she lives in Kingston.

Taxes /for the land is paid by all the brothers in Dudley's name. (The names of father's and mother's chi dren as given are in order of age, which however derald does not know.)

# Re sharing the land:

"We haven t share' the lnd up; we only live in unity as it is. " he does not think any of this land wil ever be sold: -"we would buy more instead of selling any, because what wi have is not enough.

### Cultivations:

The land is cultivated by Bradley, himself and Zillahvin only. He cultivates tomatoes, cassava, congo peas, con andx red peas, sweet potatoes and yams, on the same plot as does Bradley; they always work together, and share profits as well as crops from their plots.

## Re Dudley

Dudley a tailor in Kingston went there many years ago. He writes home frequently, and comes down sometimes also He writes chiefly to Zemina, andwas last here in December 1946. He is a big merchant tailor -D.B. Dyer ... has a big tailoring establishment on Laws St."

#### Re Lucille

Ludille now Mrs. jones married a man named Herbert Jones in 1944. -"Sh' come to see us regularly; she was here aroun' 2 weeks ago, but since sh'marry wi never go: " he does not go only because it is expensive to go to Kingston and he has no business thate to justify xxxx incurring such expenses.

# Re Zilliahvine: Zemina.

Zilliahvine shares a 2 apartment house with Zemina. This house is one of 3 left by their father. One of the other two is now "mashed down." the other, a 2 apart-ment is occupied by Bradley Dyen, who shares it with:

1. Daisy Sutherland, wife c.1.

2. Leonie Dyer dau. 21 years, to Bradley and Daisy. 3. Glenrick Dyer, son to Daisy and Bredley; 6monyhs.

He grew up with his father, brothers and sisters, his mother having died when he was 2. He was taken care &

# Present sex relationships

Asked if he was not now sharing sex relationship with any girl, he said: -"A dey keep mi character:" here he laughed a little and added -"when sayin' so a only jokin': a man don't have any character of that sort to loose, is only a soman;" i.e.-only a woman has character of that sort to loose.

Asked whether he has never had any sexrelations since he left off being friends with Annie, he said -"Mi knock them one one yes !-but mi dont have any special girl. griand: He gives money to the girls with whom he copulates, but the giving of money not demanded by the girls.
