Dyer James his parentage.

Dyer James is known in the district under his nickname "Merredy".

He is son of late Willy /Wilbert/ Dyer and Ellen Dyer. His mother is alive and interest is living in the old home besides James byer.

He has a separate home. "He is living on the same father land. I just dont know if this land share as yet."

His wife - fixexe Gwendolyn.

Her first love affair.

His house.

"His wife Gwendolyn Dyer is Mrs. Sarah Simpson who raise khm this girl. She is her adopted daughter. It Is not the xmaxxit daughter, is not the son fit of Sarah Simpson / i.e. the xmaxxexmetxparents Gwendolyn is not their daughter. I just dont know how Sarah Simpson adopted this girl. But just she raise her and she /i.e. the girl marry from her home to Merredy Dyer."

"It happen that when she was young girl and she went to Junction, to a shop. One fellow was keeping the shop. It was Bromfields shop - he was a clerk in the shop. Hr was from Russels. I dont remember his

name, but he was James."

"The girl mant go to buy some things in the shop. She was good-looking girl. And the boy fell in love and introduced her to the back part of the shop. In a back room. As man and woman - things is happening. But a next person was along with the girl. He stay outside but he see what happening. He was Philip Dyer, from Bottom. So Philip Dyer ask her what she go there and do. She just get afraid and she explained what the man do with him / = her."

"Philip Dyer come home and report to Sarah Simpson who raise the girl. And Wilbert Simpson, the son of Sarah Simpson, he took the active part. Questionned the girl a lots and she explained what really

happened happen."

"And them took the girl to the doctor. Well, the doctor report that him is quite damaged with

the man. So they come down on the boy."

"Well, the boy proved guilty and offered L20 to compromise the case - that not going further. But Wilbert Simpson who always been a foolish man, a mimic, he pursued it in court. And them tried circuit court. And the poor boy - he was really fretful. And he come to the parents, the adopted parent of the girl, and he beg him to remain it as it is and he give him L20. But Willy Simpson - he pursued it. Say: it must go in court."

"Them take the boy to court - to circuit court in Black River. The judge ask the girl: did you know what really is going to happen to you when going in the shop-room? She said: yes. And now, that word set

the boy free."

"In Jamaica here, a young girl you must have to be careful with girl when the young girl and it is first damage. They take you to court and they try you - it is vagrancy. There are nasty girls in Jamaica. Not so girls, but their parents when they learn what happen they pursue you. You have to be careful. Jamaica law is never good - them trying to kill them the poor young man."

Gwendolyn's first child for Ambrose Holness and marriage to James Dyer.

Gwendolyn and James Dyer - "they married after that final - around 8 years now since they married. The girl did have before she marry one child by Ambrose Holness, Jane Holness son. The child is with Ambrose. Ambrose Holness took the child since the girl marry to Dyer. After the girl had this child she did go and marry to James Dyer."

Gwendolyn commits adultery.

"Since that time, when she was living for 5 yerax years with Merredy Dyer, the girl - she put herself with another boy and it happen that Merredy Dyer catch the boy on the fact."

"Well, you know women have brain - you know. The girl leave him husband in the kitchen and give him the baby to hold and tell him: I soon come. Well, the man remain with the baby believing that she going to private with herself. In the other way - what he believe was really private, but it was not looking that way."

"He remained for a period of time; when he believed that she should come and she never come - he just reckon. He went then to look for the girl - for his wife then. He just go beyond the back of the house,

found her and the man - quite in harmony."

"He run towrads the man and he grab him. And he screamed out for help. Somebody run towards rescue them and found the man on the spot and he explained what really happen. So the poor man proved guilty. And he offered a little sum then just to keep normal it normal."

"Well, the man was not so foolish as the past day: days that happen with his wife. So he took the money from the boy and asked him not to be seen in his yard back again.

"And he make never come back. And the husband - he took money and put up his teeth."

"Dyer James - he have one girl before he marry. He have one child by May Sinclair in Ribbit. A girl. And the girl now marry to Angus Dyer in Dunder Hill. She was living with father all the time, till after a period of time she show a little unruly and go to live with mother. Father speak to her and she leave and marry out of her mother home."
